Motion passed 3-0. 45 46 Resolution No. 25-02 amending the 2025 Budget for SJC Fire District 3 was discussed. Chief Monin described the 47 adjustments to the current budget. Moved by Rust, seconded by Appleton, to adopt Resolution No. 25-02. Motion 48 passed 3-0. 49 50 STAFF REPORT(S) 51 Chief Monin reviewed the general fund revenues, expenses, ending cash balances and anticipated revenues. 52 53 Chief Monin reviewed the monthly operations report describing staffing, policy review and general current events 54 for the District.
